The forgoing release is binding upon me personally, as well as my heirs, executors, administrators and assigns, and all members of my family, or anyone else who might make claim on my behalf. I understand that the Race Director or other appointed personnel reserve the right to refuse entry to anyone for any reason. Entry forms must be received by October 8TH to allow time to order shirts and medals. Payments must be received IN OUR HANDS by October 18TH so that we have time to process your entry before the race

Payments may be made by check or money order. No one will be allowed to race unless the entry fee is paid.

You will receive an email confirmation of your entry in the race when your payment has been received. If you do not receive an email confirmation, please contact us by phone! 435-820-1903 or 435-564-3490.

Each runner must complete a separate form. Enter your name as it will appear on race documentation and the address at which you receive mail. Age and sex may be used for race statistics and special recognition.

Place a check mark beside the entry for which you are including payment. Your post-race meal is included in your entry fee. If you want to purchase a meal for others, write in a total for purchased meals. Total your costs.

Each runner must sign that he/she has read the Waiver. A guardian must sign for anyone under the age of 18.
